Sealed proposals shall be mailed or delivered to Ms. Lori Pederson, County Auditor for the 2020 Dickinson County Drainage District #31 Improvements Project until 10:00 A.M. on November 13, 2020, at the Dickinson County Courthouse, located at 1802 Hill Ave., Spirit Lake, IA 51360; at which time the bids will be publicly opened and read. Proposals will be acted on by the Dickinson County Board of Supervisors at the aforementioned public hearing or at such later time and place as may then be fixed.

Work to Be Done: 486 LF of 15" RCP 2000D Storm Sewer, Trenched; 473 LF of 18" RCP 2000D Storm Sewer, Trenched; 1535 LF of 24" RCP 2000D Storm Sewer, Trenched; 82 LF of 15" RCP 2000D Storm Sewer with Casing Pipe, Trenchless; 113 LF of 24" RCP 2000D Storm Sewer with Casing Pipe, Trenchless; 250 LF of Removal of Storm Sewer; 1 EA of 24" RCP Pipe Apron; 1 EA of 10" Hickenbottom Intake; 3 EA of 48"x 48" SW-513, Open-sided Area Intake; 3 EA of Remove Intake; 1 LS of Temporary Traffic Control; 1 LS of Storm Water Pollution Prevention Plan Management; 20 TON of Rip Rap, Erosion Stone; 100 LF of Removal and Reinstallation of Existing Fence, Barbed Wire; 1 LS of Mobilization; 15 Hours of Field Tile Exploration; 30 EA of Reconnection of Field Tile.

<u>Proposals</u>: All proposals shall be made on official proposal forms furnished by the Engineer and shall contain worded and figured prices for the work bid on. All proposals shall be plainly legible, sealed, and addressed to Ms. Lori Pederson, County Auditor, Dickinson County Court House, 1802 Hill Avenue, Spirit Lake, IA 51360. Bidder shall submit a Bidder Status Form with their bid. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed unresponsive and rejected. A certified check or a bid bond of a reputable bonding company authorized to do business in the State of lowa in an amount not less than ten percent (10%) of the total amount of the bid shall be included in a separate sealed envelope, plainly marked "bid bond". The bid guarantee shall be forfeited as liquidated damages if the successful bidder fails proper execution.

The checks or bid bonds of the lowest two or more bidders may be held for the earlier of 7 days after the effective date of the agreement or 61 days after the bid opening, whereupon Bid Security furnished by such bidders will be returned. Other checks or bid bonds will be returned after the tabulation of bids is completed.

<u>Performance and Payment Bonds:</u> The successful bidder must execute performance and payment bonds, each in an amount equal to one hundred (100%) percent of the contract amount to ensure a timely, efficient, and complete performance. The bonds shall be issued from a reputable bonding company authorized to do business in the State of Iowa.

<u>Liquidated Damages:</u> Liquidated damages will be assessed the contractor in the amount of five hundred dollars (\$500.00) per working day that the work remains uncompleted after the end of the contract period with due allowances for extensions due to conditions beyond the control of the contractor.

<u>Withdrawal of Bids:</u> No submitted bids may be withdrawn for a period of thirty (30) days from the scheduled closing time for the receipt of bids.

<u>Payment:</u> The Contractor will be paid monthly in an amount equal to ninety-five percent (95%) of the Work completed during the previous month according to the Engineer's estimate. Payments shall be made in the form of stamped warrants. The final payment will be made not less than thirty (30) days after completion of the Work and acceptance by the County. No final payment will be due until the Contractor has certified that the materials, labor, and services have been paid for in accordance with the Project Manual.

By virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of lowa and to lowa domestic labor to the extent lawfully required under lowa statutes, providing that the award of the contract will be made to the lowest responsible bidder submitting the lowest acceptable bid, which shall be given without regard to state or local law whereby preference is given on factors other than the amount of the bid.
