I. INTRODUCTION / HISTORY

This annexation report is being completed for Dickinson County Drainage District No. 48 (DD#48). As a result of work on the reclassification report, it was discovered there is land that is benefitting that was outside of the original boundary. These lands should be annexed.

II. DETERMINATION OF LANDS TO BE ANNEXED

The land studied is in Sections 32 & 33 of Spirit Lake Township in Dickinson County. We have studied the topography of the area and modified the boundary accordingly. Area to be annexed was determined mainly by using the old boundary map, our watershed boundary software and the last classification list the County had on record.

The areas we are recommending for annexation into DD#48 are listed on the next page of this report and shown on the map in the back of this report.

III. CONCLUSIONS AND RECOMMENDATIONS

We recommend that the trustees for DD#48 proceed with annexation of the above lands.

We also recommend that the trustees set a date for a public hearing on this annexation. All parties having an interest in the lands proposed to be annexed have the right to receive notice. At such hearing, the trustees will review the Engineer's annexation report. They will then approve the report, modify and approve the report, or reject the report. Any land annexed should be included in the reclassification. This will ensure that all property owners will pay the appropriate share of the cost for improvements and future maintenance.
